4. Description of work to be performed:
 The BHMBA will provide the volunteer hours to maintain the current biking, hiking and running trails designated as non-motorized in the locations of Buzzards Roost, Shanks Quarry, Victoria Lake, Storm Mountain and Trail 89 (section Pilot Knob to Dakota Point). Responsibilities includes pruning, raking, cutting of grass, or other means of keeping the trail corridor open to users per IBMA and Forest Service principles. Volunteers will also assist in reporting natural/unnatural damage, replace/repair carsonite signage and GPS the unmarked existing trail. BHMBA trail crew leaders must review the safe operation of hand tools and other safety protocols prior to the start of each work day. Volunteers wishing to work outside any scheduled club work day will need to contact BHMBA's trail coordinator and obtain authorization from the club to work on trail. Any trail drainage or rerouting is not allowed without prior authorization form the Forest Service.

5. The above-described work will be contributed to the Forest Service. Except as provided below, the work performed by the participants will not confer on them or on our employees, or officers, the status of federal employees.

6. We will provide the Forest Service with a list of participants and man-hours contributed to accomplish the work in item 4 above.

7. We will obtain parental or guardian consent for each individual under 18 years of age and will comply with child labor laws.

8. Jason Kingsbury is hereby designated to serve as our liaison with the Forest Service in day-to-day operations under this agreement.

9. We understand that either the Forest Service, or we, may cancel this agreement at any time by notifying the other party.

 The BHMBA strictly follows IMBA and Tread Lightly principles. It is our mission to promote mountain biking in the Black Hills. Goals include keeping up with the progression and changes in mountain biking, making mountain biking available to all ages and abilities, building and maintaining environmentally friendly and sustainable trails, and helping to promote health and activity in the youth of the Black Hills.
